\_\_\_\_\_ 3. Refrain from criminal conduct, specifically the violation of any State, Federal, Local or Municipal Law.

\_\_\_\_\_ 4. Make reasonable reparation or restitution to the aggrieved party for damage or loss caused by your offense in an amount to be determined by the court, if any, as follows:

\_\_\_\_\_ 5. Remain within the jurisdiction of the court and get the permission of the court before any change in your address or employment.

\_\_\_\_\_ 6. Enroll in adult education. Attain a G.E.D. or remain in classes until term of probation expires.

\_\_\_\_\_ 7. STAY OUT OF BARS and places where alcoholic beverages are sold and consumed on the premises; do not drink alcoholic beverages or use controlled dangerous substances (drugs) for term of probation.

\_\_\_\_\_ 8. Submit to random drug testing at your own expense. Positive result or failure to appear for test within two days is cause for probation revocation.

\_\_\_\_\_ 9. OTHER SPECIAL CONDITIONS IMPOSED BY THE COURT AS FOLLOWS:

\_\_\_\_\_ 10. Meet with probation officer once each month.

Failure to comply with the foregoing conditions may cause your probation to be revoked. If your probation is revoked, the original jail sentence may be imposed by the court. During the period of probation, you shall be subject to arrest at any time by a duly authorized law enforcement officer, either with or without a warrant, for the purpose of returning you to the court for further disposition.
